She conducted many provings in the French Homeopathic Training Institute INHF-Paris and authored already lectures and articles about her experience and methodology of educational provings.

She has been also recently elected as president of the Société Savante d'Homéopathie which aims at promoting high quality researches and education in homeopathy in France.

Peter Smith is an experienced homeopath running a large practice for integrative medicine (homeopathy, acupuncture, naturopathy) in Capetown, South Africa, before he moved to Germany where he currently oversees the field of regulatory work for Heel in Baden Baden, Germany. He is advisor to the Homeopathic Pharmacopeia Convention of the United States (HPCUS).
